GNWKCF is a public charity, a non-profit organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code. GNWKCF manages a variety of fund types for individuals, families, businesses, organizations, and community foundations. Fund types include: administrative, designated, donor-advised, field of interest, organization, and scholarship.

Affiliate Foundations

GNWKCF provides the legal 501(c)(3) structure for all foundations with an affiliate status. These local foundations receive our full services and benefits, including administrative, accounting and investment services, donor relations and legal guidance, foundation staff and board training, and more.

Agency Foundation

GNWKCF provides accounting and investment administrative services for all select established funds. Our back-office support allows the local foundations to focus on their mission as they build donor relations to help donors achieve their philanthropic goals. They are independent 501(c)(3) foundations.

Supporting Organizations

GNWKCF provides guiding oversight for these organizations who are unable to meet the IRS public-support test for being an independent 501(c)(3); our supported relationship allows them to meet specific IRS requirements. Funds are managed by GNWKCF and their full assets are compiled and accounted for on our 990, but the supporting organization is responsible for filing their own independent 990 as well. Supporting organizations have their own governing board of directors and receive similar accounting and investment support and services from GNWKCF as an Agency Foundation.

Agency Partners

GNWKCF recognizes one foundation as a partner. They are an independent 501(c)(3) foundation, but the only funds we currently manage for them are their Hansen-initiated funds that this foundation oversees for their respective county. We also recognize some organizations as Agency Partners, we reference those who have established at least one endowed organizational fund under GNWKCF directly (not under a county or community-specific foundation). GNWKCF provides accounting and investment administrative services on endowment funds of these organizations and foundations.

Celebrating 15 Years of Growth, Giving, and Impact

In 2024, we proudly marked our 15th anniversary—a milestone that reflects the dedication, generosity, and unwavering commitment of our affiliates, donors, and partners. What began with a vision to strengthen our rural communities has grown into a powerful movement of philanthropy that now reaches across 15 counties in Northwest Kansas.

Our foundation started the 2024 year with \$90,127,242 in assets, and thanks to the tireless efforts of our affiliates, we closed 2024 with \$111,432,883 in assets. This growth directly translates into greater impact, with every dollar reinvested into the communities we serve. Over the past 15 years, together we have awarded more than \$22 million in grants and scholarships, creating lasting change across our region.

Beyond financial impact, we have strengthened our foundation's capacity to serve. Since the launch of the Dane G. Hansen Foundation's part-time staffing initiative in 2021, followed by the Hansen/Patterson Family Foundation's fulltime staffing initiative in 2024, the number of managed funds has surged 155%, growing from 284 in 2022 to 438 today. Nearly all of our affiliate foundations now have a full-time staff member, ensuring that philanthropy continues to thrive at the local level.

This success is made possible by our affiliate and partner staff members—who are the heart of this movement. As we look back on 15 years of impact, we also look forward with excitement. Imagine what we will accomplish in the next 15 years!

Together, we are building a legacy of generosity, transformation, and hope for Northwest Kansas. Here's to the next chapter of making a difference—because together, we can achieve so much more!

Message from Our Hero in Chief

As we look back on the past year, we can sum up 2024 as a year of significant growth and milestones.

In 2024, we welcomed four new affiliate foundations – Graham, Logan, Norton, and Wallace – bringing our total to 13 affiliates within our 15-county service region. We saw an increase of 70 new funds, and our assets grew to \$110 million—a remarkable rise from \$13 million in 2015.

Our foundation staff and board members participated in a comprehensive SWOT analysis in early 2024, strengthening our operational structure as we prepared for anticipated affiliate growth. In March, the Hansen and Patterson Foundations announced their co-developed Full-Time Staffing Grant Initiative, providing all our affiliate foundations with the opportunity to secure full-time directors. This impactful initiative will help advance philanthropic activity throughout Northwest Kansas. By the



end of the year, we had 26 W-2 employees (GNWKCF direct staff and affiliate staff), a significant increase from 14 in 2023.

Founded in 2009, Greater Northwest Kansas Community Foundation (GNWKCF) celebrates its affiliates, partnerships, donor relationships, dedicated staff members, visionary board members, and the many success stories created over the past 15 years. To acknowledge both the growing pains and achieved accomplishments, GNWKCF marked its 15th anniversary with a special celebration for our affiliated staff members, featuring a day of team-building activities and learning. FUND TYPES

Donor Advised Funds

Donor's family can have ongoing involvement in the use of a gift. Advisors work with our professional program staff, identifying ways to use dollars from the Donor Advised Fund. Address the issues and needs the fundholder cares about most. Advisor's recommendations are submitted for approval; we then distribute grant dollars.

Unrestricted Funds

Gifts can address ever-changing community needs – including future needs that often cannot be anticipated at the time the gift is made. We evaluate all aspects of community well-being – arts and culture, economic development, education, environment, health and human services, neighborhood revitalization, and more. The flexibility of unrestricted gifts enables each community foundation's program experts to respond to the community's most pressing needs, today and tomorrow.

Field of Interest Funds

Gifts can be targeted to address needs in an important area of community life. Arts, Food Bank, Youth Activities, Healthcare. Identify personal interest areas when making gifts; a grant committee awards grants to qualifying community organizations and programs that are making a difference in the selected area.

Designated Funds

A donor may direct gifts to a specific charitable nonprofit organization - either for unrestricted use or with guidelines. One may designate funding for a senior center, museum, church, or any qualifying nonprofit charitable organization. The named designee is the sole recipient of all grant funding.

Organizational Funds

A qualifying non-profit organization who meets the IRS requirements, this includes 501c3 public charities, education, government, and religious entities, may establish an organization "savings" account for its own benefit. Organization funds may be established as non-endowed or quasiendowed, where only organization dollars are accepted for contributions directly into the established fund. Alternatively, it may also be established fully endowed, thus allowing outside donors to assist in growing the fund, designated for the organization's benefit. The named organization is the sole recipient of all grant funding.

Scholarships

Gifts can be invested in a community's future and show students they are cared for, all with the guidance and personal services of the community foundation. Donors determine the criteria students must meet to receive the Scholarship. With this type of assistance, students achieve their academic and career-oriented goals – from preschool to postgraduate work.

Establish a fund in your name!

Any of these funds can be established in the donor's name, or in the name of a family member, an organization, or in honor of someone. All grants distributed from the fund established— today and in the future— are then awarded to charities in the name of that fund. It's a great way to always be involved with, and remembered for, community investment.

Qualifying organizations to receive grant funding include 501c3 public charities, education, government, and religious entities.

Celebrating Generosity: The Poore Family Farms Fund

The story of the Poore Family is one deeply rooted in the soil of Osborne County. Seven generations have tended the ground on this site homesteaded in 1882 near Alton, Kansas. Since then, the Poore Family has passed down their love for agriculture and dedication to the land through generations. While farming practices have evolved from raising crops, milk cows, hogs, and chickens to 100% no-till crops with a cow/calf operation, the Poore Family's dedication to the land and farming remains unchanged. What began as a modest family farm has grown into a legacy of hard work, community involvement, and a commitment to cultivating the future.

In 2024, the Osborne County Community Foundation (OCCF) proudly welcomed a new addition to its family of funds: the Poore Family Farms Fund. This endowed fund was established to honor the legacy of Emery Poore and his family's deep connection to agriculture and education.

Emery Poore is more than a farmer; he is a visionary and a community leader who has instilled in his family a profound respect for the land and the value of education. A lifelong resident of Alton, Emery actively supported local initiatives and cherished his involvement with Future Farmers of America (FFA) during his youth. His legacy continues through his son, grandson, and great-grandchildren, all of whom have followed his path in agriculture and FFA, carrying forward the traditions he holds dear.

Craig Poore, Emery's grandson who played a key role in establishing the fund, shared his thoughts on its importance. "This fund is a way to honor my grandfather's lifelong dedication to farming and education. It's about giving back to the community that has been such a big part of our family's story and ensuring the next generation has the resources to succeed," he said.

The fund will support USD 392 Osborne County School's FFA program, including:

- Equipment to support vocational training programs to ensure students have access to state-of-the-art tools and technology.
- Essential materials and supplies to enhance hands-on learning experiences.
- Professional development for vocational teachers and student development via conventions, judging opportunities, and other initiatives.

Anyone who shares the Poore Family's passion for agriculture and education is encouraged to contribute to the fund. Every donation, no matter the size, strengthens its impact and helps cultivate a brighter future for local students. Contributions can be made through the OCCF website or by contacting the foundation directly.

The Poore Family Farms Fund stands as a beacon of community spirit, celebrating a rich agricultural heritage while fostering growth and opportunity for the next generation. Emery Poore's legacy will continue to grow, just like the fields he once farmed, ensuring that the values of hard work, education, and community endure for years to come.

Honoring a Legacy: The Lisa Scott Memorial Scholarship

A Tribute to Lisa Scott

In February 2020, Berna Scott, mother of Lisa Scott, and Virgil Scott Jr., Lisa's brother, established the Lisa Scott Memorial Scholarship through the Wallace County Foundation to honor Lisa after she passed away on September 25, 2019. The inaugural scholarship was awarded in May 2020 to Haylee Hennick. Since then, a \$500 scholarship has been granted annually to a graduating senior or former graduate of either Wallace County High School (USD 241) or Weskan High School (USD 242).

Lisa Scott was born on September 29, 1964, in Tribune, Kansas, to Virgil Allen Scott and Berna June (Cox) Scott. Raised on the family farm south of Wallace, she attended Harrison Flats School, Sharon Springs Elementary School, and graduated from Wallace County High School in 1982. Lisa faced many significant health challenges, having open heart surgery when she was 18 months old in 1966, again when she was 17 years old, and being diagnosed with schizophrenia when she was 23. After furthering her education at Garden City Community College, Lisa was a certified nurse assistant and certified medical assistant for a few years, at nursing homes in Sharon Springs, Minneola, and Garden City.

In honor of Lisa's memory, her family—Allen and Berna Scott of Sharon Springs, KS; sister Paula (Joe) Korbe of Garden City, KS; and brother Virgil Jr. (Diane) Scott of Broomfield, CO—created this endowed scholarship fund. The scholarship provides a lasting legacy to help students from Wallace County pursue secondary education.

GNWKCF works with 15 of the 26 counties, and Greater Salina Community Foundation works with the remaining 11 counties.

2024 Community Foundation Initiatives:

Community Grant Funds: Dane G. Hansen Foundation gives \$25,000 twice a year promised through 2026; provided the respective communities actively participate in the Strategic Doing process.

Matching Endowment Funds: Dane G. Hansen Foundation matches \$1 for \$1 up to \$50,000 during a community foundation declared Match Month, promised through April 2029. Also as of May 2022, offers incentive grants of \$45,000 for the local foundation's operational endowment fund and \$5,000 for their general operating fund. On top of that, the Patterson Family Foundation matches \$1 for \$1 up to \$70,000 during a community foundation declared Match Month.



NWKansas Gives: This initiative was introduced in 2019 to offer technical assistance and education to area community foundations, by Dane G. Hansen Foundation, to capture the transfer of wealth occurring over the next few decades. Through this program, donors wishing to make a charitable gift that impacts Northwest Kansas have access to estate planning attorney, John Griffin of Stewardship Counseling, to help design a plan.

Staffing Grants: Dane G. Hansen Foundation is offering optional operational grants to the 26 county-wide community foundations. Foundations may apply for a \$10,000 grant per year (in years 2021-2025) to provide funding for a part-time staff or consultant position to assist the foundation with general operations. In 2024, Dane G. Hansen Foundation and Patterson Family Foundation partnered to provide the community foundations the opportunity for full-time staffing grants, up to \$60,000, promised through 2026.

Patterson Family Foundation Partnership



The Patterson Family Foundation, based in Kansas City, Missouri, is a family-led foundation that extends the legacy of Neal and Jeanne Patterson. JoEllyn's primary focus surrounds asset growth and increased visibility of the Community Foundation. In addition to supporting community projects and initiatives, the ACE Foundation is spearheading the Strategic Doing Process. Increased leadership and support of emerging leaders was identified as a need across the county. ACE promoted the Nex-Generation Round Up for Youth Internship program,

proudly increasing the number of participating businesses to ten! ACE Foundation and Rawlins County Economic Development are partnering to implement the Main Street Program through Kansas Department of Commerce in Atwood. This framework provides technical assistance, access to financial support, and initiatives to promote a thriving and sustainable downtown area.

GRANT FUNDING PURCHASES AERATOR - The Lillie Solko Conservation (field of interest) Fund was established in 2017 to support the betterment of soil health or conservation of the Earth. In 2024 the Rawlins County Soil Conservation District was able to purchase a Ranchworx aerator, supported in part by a \$10,000 community grant and the Lillie Solko Conservation Fund!

A Word from the ED

2024 has been a year of growth, generosity and community impact for GROW Decatur County Foundation. With the hiring of a new director and continued support from donors, GROW has strengthened our role in building a brighter future for Decatur County.

This year GROW awarded \$135,413 in grants to support a variety of local projects, including public safety, education and community development. From funding new playground equipment and classroom resources to providing essential safety gear for local fire departments, these grants reflect GROW's commitment to making a lasting impact.

Access to quality healthcare is essential for the future of Decatur County, the Decatur Community Fund for the Recruitment and Retention of Health Professionals was created to ensure long-term solutions for attracting and keeping medical professionals in our community. This fund was established by a forward thinking donor and marks a significant step toward strengthening local healthcare and ensuring that Decatur County remains a place where residents can receive the care they need close to home. This fund stands as a testament to the power of forward thinking philanthropy and community driven solutions.

The GROW Decatur County Foundation is proud to support the safety of our communities and the first responders who protect them. This year, we awarded grants to local fire departments to ensure they have the essential equipment needed to do their jobs safely and effectively. The Jennings Fire Department received \$10,000 to replace outdated helmets with modern, lightweight and more comfortable helmets, enhancing firefighter safety and performance. The City of Oberlin Fire Department was awarded \$15,000 to purchase an air compressor filling station, new air tanks and self-contained breathing apparatus (SCBA) masks- critical tools for emergency response.

GROW is committed to supporting local schools and ensuring that students have the resources they need to learn and thrive. This year, we awarded \$25,000 to Oberlin Elementary School to help fund a new playground with ADA-compliant equipment, creating a safe and inclusive space for all children to play. Additionally, Decatur Christian Academy received \$7,500 to equip it's newly built school with desks, technology and a new outdoor playground, providing students with essential tools for learning and growth.

2024 was a big year for NCCF. Highlights include affiliating with GNWKCF and having a record number of new donors during November's Match Month! From June - September, we offered a Match Program for new and existing funds to raise \$5,000 and receive an equal match. NCCF's Hansen Community Grant Fund awarded \$2,064.76 to Eisenhower Elementary School (USD 211) to support library upgrades, including the installation of an outdoor Story Walk and open-faced bookshelves.

The Norton Mini Speedway is a great example of how a few dedicated people can make a BIG difference. Go-kart racing is a growing regional activity as it engages people of all ages and provides family-fun entertainment. For years, several families in Norton County have been traveling across the region to participate in races. In 2024, they developed a plan to build a racetrack in

Norton, where they could practice and host races. They raised local funds, including a grant from NCCF's Hansen Community Grant Fund, and donated their time and labor to form the track inside the car racetrack at the Elmwood Park in Norton. In September, when we announced our 5 for 5 Match Program, they decided to take advantage of the opportunity and began building their fund. This fund will grow with them as they continue to make advancements to the facility and their vision of bringing spectators to Norton for race nights!

The Osborne County Community Foundation (OCCF) has long been a cornerstone of charitable giving and community growth in Osborne County. Established in 2017, our goal is to connect generosity with community needs, ensuring a brighter future for generations to come. Through our grants, partnerships, and donor-supported funds, OCCF plays an active role in addressing local needs and fostering positive change. Whether it is supporting youth programs, enhancing public spaces, or investing in education and the arts, our work reflects the values and aspirations of Osborne County residents.

This year, OCCF has been particularly active in engaging the community. From hosting events like legacy dinners that celebrated local agriculture and philanthropy, to connecting with local organizations and awarding grants for projects that strengthen our communities, we worked to make a difference.

Throughout the year OCCF worked with donors and local organizations to establish nine new endowed funds that will benefit Osborne County in perpetuity. In addition, 35 grants were awarded for community projects. From new housing initiatives to local community events, these grants infused money in projects that enhanced our county.

Legacy Dinner Series

In Fall 2024 OCCF hosted its first Legacy Dinner Series, a special series of farm-to-table events held in Osborne, Downs, and Alton. The dinners brought community members together to celebrate local agriculture, connect with neighbors, and learn about the transformative power of philanthropy. Each event highlighted our mission of supporting Osborne County through charitable giving, and attendees were treated to locally sourced meals that underscored the richness of the region.

A highlight of the series was the opportunity to hear from Betsy Wearing, Coordinator of Programs, Communications, and New Initiatives at the Dane G. Hansen Foundation. Betsy shared valuable insights into the intergenerational transfer of wealth, a pressing topic for rural communities like ours. She emphasized the

importance of planning for the future, encouraging families to consider how their legacy could support the causes and communities they care about most. Her message resonated deeply, sparking conversations among attendees about the ways philanthropy can preserve our community values and ensure a thriving future for Osborne County.

Alton's Centennial Garden: A Community Effort

The future is bright for a community project dating back generations.

In March 2021, the revitalization of Alton's Centennial Garden began as a project through Alton PRIDE. The effort was supported by the generosity of Solomon Ridge Farms as the primary donor and a contribution from the Sarver Charitable Trust, along with community members who purchased the large juniper trees.

Ginger and Doug Howell led the efforts to tear out the old landscaping and install new greenery, transforming the space into a refreshed and inviting garden for the community. Community volunteers played an essential role, helping to plant, weed, and maintain the garden to ensure its ongoing success.

Garden's Roots Run Deep

The origins of Centennial Garden stretch back decades when it was created prior to the 1970 Bull City Centennial. It featured flowers that were planted and tended by Violet Holtslander, Maryellen Boland, Leola Clausen, Nadine King, Sylvia Tyler, and others. Later on, Alsa Hartzler became the flower garden's caretaker until her death in 2006.

These women, with their green thumbs, hand-watered and planted annuals from seed each year, creating a flourishing centerpiece for Alton. Their legacy inspired the recent revitalization and continues to guide the community's vision for the future.

New Life for Garden Project

After the initial garden transformation was completed community volunteers have donated time and funds to maintain the project. Seeing the need for a sustainable stream of income for this project, Mike and Lori Adams established the Welch Family Memorial Fund through the Osborne County Community Foundation this year.

The new fund honors Lori's mother, Marilyn Welch, and provides a sustainable, annual stream of income to the City of Alton for maintaining and enhancing Centennial Garden. This ensures that supplies like annuals, bulbs, and mulch can be purchased every year without financial strain. Community members and supporters can help grow the fund, ensuring its sustainability and enabling future improvements. Expanded landscaping, pathways, benches, and even a professional sprinkler system could become a reality as the fund grows. This flexibility ensures that Centennial Garden will not only be maintained, but can also evolve to meet the community's vision, serving as a vibrant and cherished space for generations to come.

Every February, the Matt Driscoll Fund helps save lives in Russell County by offering free Coronary Artery Calcium Scans at Russell Regional Hospital to help identify heart health issues and prevent future damage to your heart.

Honoring the legacy of Matt Driscoll, his family established a charitable fund in his memory to benefit the Russell County area. Matt grew up in Russell and was active in school and community affairs, an honor student and an Eagle Scout. He attended the University of Kansas and then traveled to New York where he was employed by Sotheby's. After the events of September 11, Matt wanted a change and to be closer to Kansas. He graduated from Le Cordon Bleu culinary institute and taught at NCK Technical College. Matt was also employed at the Driscoll Law Office and a member of the Russell City Council.



Matt's zest for life and intrepid adventures are reflected in the grants his fund supports, including free movies at the Dream Theatre, Thanksgiving and Christmas meals at the food pantry, underwriting musicals in the Ad Astra Festival, and free heart health screenings so others may live a full and healthy life. "IF YOU BUILD IT, THEY WILL COME"

In October 2024, the Sheridan County Community Foundation celebrated the completion and opening of the Sheridan County Daycare Duplex Facility in Hoxie's Sunrise Addition. This milestone was the result of a three-year effort to expand childcare options in the county.

The Foundation, led by Executive Director Karl Pratt, began addressing childcare shortages in 2021. Their solution: building a duplex facility to house two private daycare businesses. With land donated by Sheridan County and funding from various partners—including \$200,000 each from the Dane G. Hansen Foundation and Kansas Children's Cabinet—the project included construction, landscaping, play areas, and fully furnished interiors. The facility was built by Bainter Construction, with outdoor play areas completed by Campbell Construction. Each unit features fenced yards, turf and rubber play zones, and storage sheds. In November 2024, the first tenants, Jordan Ewers of The Jungle Gym and Caitlin Schwagerl of Kingdom Kiddos, began operating their daycares.



To ensure long-term support, the Foundation created the

Sheridan County Child Care Fund, an endowment to maintain the duplex and eventually provide grants to other local daycare providers.

This project complements earlier efforts, including Hoxie First Steps Daycare, a school-owned facility launched in 2022 to serve USD 412 staff and the community. Through collaboration and vision, the Foundation is making Sheridan County a more family-friendly community, meeting critical childcare needs, and investing in its future.

"TEAMWORK MAKES THE DREAM WORK!"

With funding from the Dane G. Hansen Foundation and the Patterson Family Foundation, the Sheridan County Community Foundation secured a grant for the Executive Director position, filled by Karl Pratt. This allowed the Foundation reallocate funds to create two new positions: Program Officer and temporary Special Projects Coordinator.

In August 2024, Kerissa Payne was hired as Program Officer. Payne, her husband Charlie, and their children Sadie and Harper relocated to Hoxie from Ohio in 2023. They own Covey Rise Farms, LLC, specializing in dry-aged beef and farmto-table products shipped nationwide. Payne now leads economic development initiatives to foster sustainable growth in Sheridan County.

Sofia White joined as Special Projects Coordinator in November 2024. A native of Atwood, she previously worked in Hoxie as a chef at The Elephant Bistro and Bar before opening her own food truck, Blue Blaze Pizza. White and her husband, Jeremiah, returned to Hoxie in 2023 with their children, with their children,

Astrid and Atticus, after time in Atwood. She co-leads the Foundation's Strategic Doing efforts, serves as a liaison between project committees and the Foundation, and supports marketing and graphic design initiatives.

Pratt, the Foundation's first staff member since 2018, has transitioned to focus on donor relations, planned giving, and supporting local organizations with training and resources.

The Foundation team recently moved to Bottle KAP Studios at 721 Main Street in Hoxie, offering a collaborative space for meetings and small events.

Making Magic with Grants

The foundation awarded 81 grants totaling a whopping \$280,693. These funds supported everything from sprucing up classrooms to boosting community events, spreading joy and opportunity throughout Sherman County-one grant at a time.

A Big Welcome to New Funds

In 2024, the foundation added 11 brand-new funds. Each fund represents a unique commitment to addressing local needs and fueling progress. By creating new funds, donors are able to help support diverse causes and ensure that resources are available for future generations.

Going Full-Time Fabulous

This year marked a milestone with the foundation's first full-time executive director. Tina Wolak joined SCCF in July of 2024 as their first full time director. Having someone dedicated to the role full-time ensures that operations remain focused, ideas keep flowing, and the foundation's impact continues to grow.

Home Sweet Office

The foundation settled into its new office at 106 East 11th Street. The SCCF board felt it was super important to have a presence in downtown Goodland. The welcoming space will be a hub for collaboration, meetings, and dreaming big for Sherman County's future.

Match Day/Month Momentum

The community's generosity shone brightly in 2024. Between Match Day and Sherman County Shares Month, over \$187,000 was raised. Thanks to a 3-to-1 match, from Dane G. Hansen and Patterson Family Foundations, these contributions created an even bigger impact, strengthening the Sherman County Strong Endowment Fund and supporting local projects.



In September 2024, USD 352 was awarded \$10,000 to fund their "Band Jumpstart Project. The school's band program has experienced an unprecedented influx of student participation, compared to the previous year. The new band director, Elliott Whisenant is serving 170 students a day! This surge reflects the students' increasing interest in music education and being a part of one of the biggest clubs at Goodland Jr Sr High. This created a significant challenge: the current inventory of instruments and supplies was inadequate to meet the needs of the expanded program. SCCF was happy to step in and help fund this project.

In August 2024, the Goodland Senior Center was granted \$8,000 to purchase a new range for their commercial kitchen. The old range was over 40 years old and while working, it wasn't efficient and needed an upgrade. Pictured right are some Plumbing Technology students from Fort Hays Tech Northwest who help move out the old range, move in the new range, and gained some hands-on experience with the installation. This is a great collaboration that SCCF is happy to be a part of.

Why Your Support Matters

Over the past two years alone, the Smoky Hills Community Foundation has granted nearly \$300,000 back to Ellsworth County. These funds have supported critical projects that meet pressing needs, strengthen local organizations, and improve lives. This year alone, several impactful initiatives were made possible:

- Ellsworth Health and Recreation Center: A \$12,307 grant for energy-efficient lighting and climate control upgrades, enhancing the facility for everyone.

The results were extraordinary: \$247,427 raised and a 51% increase in donors compared to 2023. 2024 Spotlight Grant - ECMC's New Inpatient Therapy Room

We are proud to feature our 2024 Spotlight Grant, a \$10,680.34 investment that helped Ellsworth County Medical Center create a dedicated inpatient therapy room, making rehab more accessible and convenient. Equipped with therapy mats, parallel bars, an upper/lower extremity bike, and tools for strength, balance, and mobility, this space is built for faster recovery and greater independence.

Having therapy right on the unit means patients get the care they need without the added stress of traveling. We are honored to contribute to ECMC's long-term vision, ensuring Ellsworth County's healthcare remains local, impactful, and a cornerstone of community well-being.

The Phillips County Community Foundation (PCCF) experienced an extraordinary year of support in 2024 and is excited to carry this momentum into 2025, continuing its mission to strengthen all aspects of life in Phillips County.

The foundation wrapped up its most successful Match Your Money Month fundraising campaign in October. The community came together in an incredible show of support, with generous contributions from donors and sponsors, as well as enthusiastic participation in every fundraising event-surpassing the \$70,000 goal!

Growth in Grant Opportunities

PCCF saw remarkable growth in 2024 in the funds awarded, including the introduction of a new Mini-Grant program. This program provided up to \$1,000 in funding through a simplified application process. Twelve recipients benefited from Mini-Grants, supporting diverse initiatives such as youth sports programs and small local beautification projects.

Developmental Services of Northwest Kansas, Inc. (DSNWK), founded in 1967, has been a story about people: serving, advocating, supporting, educating, and simply helping people. In 1967, a group of spirited parents decided that their children who had intellectual and developmental disabilities (I/DD) deserved normal lives. They banded together and started a movement.

This action is still visible today because of one element: its mission. The mission that graced the movement back in the 60s has

undergone changes through the years; however, the purpose has remained the same: "To advocate with persons with disabilities and those who care about them by planning and supporting a life of dignity, interdependence and personal satisfaction in the community."

DSNWK has been a partner organization to GNWKCF since 2014 with the establishment of the Developmental Services of Northwest Kansas Fund. Today, this fund is known as the DSNWK - Live With Purpose Fund. In 2017, to celebrate 50 years, DSNWK launched a fundraising campaign to build the fund known today as the DSNWK - Jim and Rose Blume Endowment Fund which was established in February 2018. Also in 2018, the DSNWK - Andy Betzen Memorial Endowment Fund and the DSNWK - Joey Weber Endowment Fund were established. Each of these funds help support the continued DSNWK mission. DSNWK offers support to meet the needs of individuals who experience lifelong mental or physical challenges that are diagnosed before the age of 22. Support includes instruction and help with self-care, skill building, communication, mobility, and employment so individuals can live and be active in their communities. DSNWK serves all age groups in the counties of: Cheyenne, Decatur, Ellis, Gove, Graham, Logan, Norton, Osborne, Phillips, Rawlins, Rooks, Russell, Sheridan, Sherman, Smith, Thomas, Trego and Wallace. A Hoyer Portable Lift System was purchased thanks to the generous support of the Sheridan County Community Foundation (SCCF) and the Norton County Community Foundation (NCCF). These grant awards (\$1,931.99 from SCCF and \$2,753.29 from NCCF) support staff with the tools to better perform transfers of individuals in services who require lifting and transferring as they navigate their environment and better meet their daily needs.

Both the ACE Foundation (ACE) and the Russell County Area Community Foundation (RCACF) awarded DSNWK grants for the purchase of medical supplies and equipment for training. These grants (\$681.04 from ACE and \$1,000.00 from RCACF) will enhance the quality of the DSNWK training program and will better equip DSNWK employees to respond to emergency situations as they arise.

A \$1,528.99 grant from the Graham County Community Foundation was used to purchase a wheelchair drum scale. The scale directly benefits the individuals receiving services by simplifying their use of this device at Kobler Developmental Center in Hill City. The drum scale allows individuals with mobility issues to either use their wheelchair or walker while their weight is obtained.

McDonald Community Development, Inc. (McD) was active in 2024. pushing the boundaries with community development. Our exciting year featured three main events. First, the geothermal greenhouse entered its experimental phase in the latter half of 2024, when we tested a variety of fruits and vegetables for optimum growth. We learned the greenhouse will accommodate most plants long past the outdoor growing season. This experience provides us a basis for a grow plan in 2025, when we narrow the number of fruits and vegetables grown and begin distributing the harvest in a farmers' market format.

Second, McD was able to acquire, fundraise, and pay for the demolition of three dilapidated houses in the same block in McDonald. Clearing blight paves the way for new housing opportunities in the future. Third, McD participated in a matching campaign to grow our endowment fund. Thanks to several key donors, we were able to surpass our fundraising goal. McD has big plans for 2025, including planning for a playground and walking trail, exploring the feasibility of renovating a historic main street building, and developing a functional website.

Bird City Takes a Big Step Towards a New Health Clinic

Bird City is on an exciting journey to enhance its healthcare infrastructure with the construction of a new health clinic in the coming year. Spearheaded by the Bird City Century II Development Foundation (BCCII) in collaboration with Cheyenne County Hospital, this project promises to bring significant benefits not only to the Bird City community but to Cheyenne County as a whole.

A Vision Taking Shape

The new health clinic is set to be a little bigger and more accommodating than existing facilities, addressing the growing needs of the community. This project has been meticulously planned and developed over the past four years, with both BCCII and Cheyenne County Hospital working tirelessly to turn this vision into reality. Community Effort and Support Fundraising efforts have been crucial to the project's progress, and the community's response has been overwhelmingly positive. So far, over \$447,244 has been raised, showcasing the strong support and commitment of Bird City's residents and stakeholders.

What to Expect

While specific details about the clinic's features and services will be unveiled soon, residents can look forward to a modern facility equipped to provide comprehensive healthcare services. The new clinic aims to improve accessibility, reduce travel times for medical care, and offer a welcoming environment for patients. Stay tuned for more updates on the Bird City Clinic Project. With continued community support and collaboration, Bird City is well on its way to achieving a healthier future for all.

Endowing Childcare: Building a Brighter Future for Bird City Families

In 2024, the Bird City Century II Development Foundation (BCCII) participated in the Patterson Family Foundation's Rural Community Foundation Match Program, which provided up to \$70,000 in matching funds to qualifying community foundations. This initiative, offered in partnership with the Kansas Association of Community Foundations (KACF), aims to inspire philanthropy and strengthen rural communities across Kansas and northwestern Missouri.

Thanks to this opportunity, BCCII secured \$70,000 in matching funds from the Patterson Family Foundation through Match Day fundraising. BCCII then matched this amount with an additional \$70,000, resulting in a \$140,000 endowment dedicated to supporting childcare services in the community. This endowment will help sustain and grow resources for Cougar Cub Daycare, ensuring access to quality childcare for generations to come.

Cheylin Gyms Get a Fresh Look with New Mats

The Cheylin gyms in Bird City and McDonald received a fresh upgrade in Fall 2024 with the installation of new floor mats, enhancing safety and improving the look of both facilities. The mats feature updated designs and added padding, ensuring better protection for athletes during practices and games.

This project was made possible with the support of the Bird City Century II Development Foundation (BCCII), which was pleased to provide grant funding for part of the upgrade. These improvements reflect Cheylin's continued dedication to maintaining quality athletic spaces for students and the community. The new mats will benefit a variety of programs, from youth activities to high school athletics. Friends of Cottonwood Ranch

When John Fenton Pratt started building Cottonwood Ranch in 1885, he had no idea that it would someday tell the story of his family.
